Wholesale Information & Dealer Agreement

Pamela's Parasols for resale are shipped individually packaged in a presentation box with Venus logo. Decorator Parasols may be ordered in assortments to meet wholesale minimums.

Initial order must include 20 boxed Pure and Simple parasols.

Fans

White Rice Paper Fans are packaged solo in individual gift bags or in gift boxes of 12.

Branding & Resale Pricing

You must resell product for a minimum of the online price and clearly display Pamela's Parasols' name and logo. Please see price list for wholesale & retail prices and minimums. Prices are subject to change without notice.

Orders & Payment

Initial orders are pre-paid and include one display Pure and Simple parasol. Domestic reorders are net 30 days. All International orders must be pre paid.

Order minimums:

U.S. & Canada \$600 initial order [must include 20 boxed Pure and Simple]/ \$200 reorders. See order form 1.

International \$1200 initial order [must include 20 boxed Pure and Simple]/ \$600 reorders. See order form 2.

Display & Web Listing

Current accounts with a minimum of \$1000 in annual orders receive a listing on the Pamela's Parasols website.

Refund & Return Policy

Due to the nature of special events Parasols and fans are not returnable or refundable. Minor imperfections are an aspect of rice paper parasols and are part of the parasol's character. Defective product is at the discretion of Pamela's Parasols and will be replaced only within 7 days of receipt of shipment. A return authorization number is required for all returns.

Shipping charges

All wholesale orders are shipped FedEx Ground unless otherwise specified. Shipping charges are calculated at time of order. All charges, customs fees and shipping must be paid by customer regardless of whether order is claimed. Shipping time is approximately 4 to 5 days within continental U.S., 7 to 10 days Internationally.

International customers must supply a FedEx or UPS account number to pre pay all shipping and customs fees.

Arrival

Orders take 7 - 10 business days to process, before shipping, depending on inventory.

Dealer Agreement must be on file before orders are processed. Pamela's Parasols may, in its sole discretion, accept or reject any Dealer Agreement for any reason at any time without any liability or obligation whatsoever, to any individual and/or entity, including without limitation, to representative or to any entities seeking to purchase advertising.
